1. Apologies for absence were received and accepted from Cllr Pickard
2. No Declarations of Interest in items on the agenda were received
3. No members of the public were in attendance
4. Planning – The Council considered planning applications received from RDC and NYCC since the previous meeting
 - a) 15/00224/HOUSE Erection of two storey extension to east elevation and single storey garden room extension to south elevation, following demolition of existing single storey extension. Knavesmire View Back Lane Harome Helmsley YO62 5JA

The Council had no objections to this application
 - b) 15/00263/FUL Erection of a two storey side extension to west elevation and alterations and additions to doors and windows of the existing farmhouse, erection of detached triple garage block, dismantling and part rebuilding of existing former agricultural buildings to form additional domestic accommodation and 2no. bedroom self contained staff accommodation and erection of barn and block of 3no. stables with tack room and feed store. Greystones Main Street Harome York North Yorkshire YO62 5JF

 - c) 15/00264/LBC External and internal alterations to existing farmhouse to include erection of two storey side extension to west elevation, rebuilding of existing brick chimneys, secondary glazing to front elevation windows, replacement and additional timber windows and doors to other elevations, alterations to internal layout and dismantling and part rebuilding of existing former agricultural buildings.
